





- KPI's
 - METRO had 11 accidents in February of 2020 compared to 8 accidents in 2019
 - 6 of those accidents were deemed preventable compared to 3 preventable accidents from 2019
 - METRO is traveling 91,885 miles between preventable accidents in February 2020 compared to 99,421 miles between preventable accidents in 2019

- There were 3 work related Employee Injuries in February of 2020 compared to 5 Employee Injuries in 2019
- There was 1 Passenger Injury in February 2020 compared to 2 Passenger Injuries in February of 2019
